At the Government House, at Wellington, this eighteenth day of August, 1913.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by section forty of the Public Reserves and Domains Act, 1908 (hereinafter termed "the said Act"), it is enacted that the Governor may from time to time, with respect to any public domain, appoint such persons (not exceeding nine) as he thinks fit to be a Domain Board having, subject to Part II of the said Act, control of such domain :

And whereas by an Order in Council made on the thirteenth day of June, one thousand nine hundred and three, and published in the *New Zealand Gazette* of the twenty-fifth day of June, one thousand nine hundred and three, a Domain Board was appointed to control the Purangi Domain :

And whereas the period for which the said Board was appointed expired on the twelfth day of June, one thousand nine hundred and thirteen :

And whereas it appears expedient to again appoint a Domain Board to control the domain :

WHEREAS by section forty-seven of the Public Reserves and Domains Act, 1908 (hereinafter termed "the said Act"), it is enacted that the Governor may from time to time, by Order in Council gazetted, appoint any local authority to be the Domain Board having, subject to the said Act, control of any public domain :

And whereas by an Order in Council made on the twenty-eighth day of July, one thousand nine hundred and thirteen, and published in the *New Zealand Gazette* of the thirty-first day of July, one thousand nine hundred and thirteen, the land described in the Schedule hereto was brought under the operation of and declared to be subject to the provisions of Part II of the said Act :

And whereas it appears expedient to appoint a Domain Board to control the said domain :

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, in exercise of the powers conferred by the said Act, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby appoint
