WHEREAS under the provisions in that behalf of sec-tion one hundred and eighty-eight of the Public Works Act, 1908, the middle-line of a portion of the Midland Railway between Otarama and Jackson's was defined by a

Proclamation dated the eleventh day of December, one thou-sand nine hundred and eight, and published in the *New* Zealand Gazette No. 102, of the seventeenth day of the same month :
