Any one of the following persons is held to be duly qualified: (a) Members and lake members of the Nobel Committee of the Norwegian Parliament, as well as the advisers appointed at the Norwegian Nobel Institute; (b) members of Parliament and members of Government of the different States, as well as members of the Interparliamentary Union; (c) members of the International Arbitration Court at the Hague; (d) members of the Commission of the Permanent International Peace Bureau; (e) members and associates of International Peace Bureau; (e) members and associates of the Institute of International Law; (f) university professors of political science and of law, of history, and of philosophy; and (g) persons who have received the Nobel Peace Prize.

The Nobel Peace Prize may also be accorded to institutions

According to the Code of Statutes, § 8, the grounds upon which any proposal is made must be stated, and handed in along with such papers and other documents as may therein be referred to.

According to § 3, every written work, to qualify for a prize, must have appeared in print.
