7. The term "racing year" means a period of twelve months, commencing on the 1st day of August in each year.

8. The applicants for a license must satisfy the Minister

that due provision has been made for the conduct of the proposed race meeting, and that the date or dates proposed are not coincident with dates fixed for race meetings at other neighbouring places. The applicants should in general obtain from the authorities of the racing or trotting con-

obtain from the authorities of the racing or trotting conferences respectively approval of the proposed programme and dates prior to presenting the application.

9. Nothing herein contained shall be so construed as to prevent the Minister of Internal Affairs from imposing on the issue of any license any other conditions which he thinks fit in the particular case.
