## A PROCLAMATION.

HEREAS the lands specified in the first column of the Schedule hereto are State forests under the control of the Commissioner of State Forests appointed under the State Forests Act, 1908 (hereinafter termed "the said Act"), and the said lands are now no longer required for State-forest purposes: And whereas plans showing the extent and position of the said lands and a statement of the reasons why they are no longer required for State-forest purposes, have been laid before both Houses of Parliament for a period of thirty days, and no resolution has been passed by either of such Houses objecting to the issue of this Proclamation:
