Regulations for Deer-shooting, Buller.

LIVERPOOL, Governor.

TN exercise of the powers vested in me by the Animals L Protection Act, 1908 (hereinafter called "the said Act"), I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, do hereby make the following regulations prescribing the deer-shooting season in that part of the Buller Acclimatization District east, or Westport side, of the Buller River, and the conditions affecting the same, and also the form of license and the fee payable therefor.

REGULATIONS.

1. RED-DEER stags may be taken or killed within that part of the Buller Acclimatization District east, or Westport side, of the Buller River from the 16th March, 1914, to the 30th April, 1914 (both days inclusive). 2. Licenses to take or kill such deer may be issued by the

Licenses to take of kin such deer may be issued by the Ohief Postmaster at Westport, on payment of a license fee of £1, in the form prescribed in the Schedule hereto, and subject to the said Act and these regulations; provided that not more than one such license shall be issued to the same person.

3. No licensee shall take or kill more than two stags.
4. No hind or fawn shall be taken or killed on any pretext whatever; and no licensee shall allow any dog to accompany either himself or any attendant he may have with him.

Regulations for Deer-shooting, Grey District.

LIVERPOOL, Governor.

In vertice of the powers vested in me by the Animals Pro-tection Act, 1908 (hereinafter called "the said Act"), I, Arthur William de Brito Savile, Earl of Liverpool, the Go-vernor of the Dominion of New Zealand, do hereby make the following regulations prescribing the deer-shooting season in the Grey District Acclimatization District, comprising the County of Grey, and the conditions affecting the same, and also the form of license and the fee payable therefor.

REGULATIONS.

1. FALLOW-DEER bucks may be taken or killed within the Grey District Acclimatization District from the 16th day of March, 1914, to the 15th day of May, 1914, both days inclusive.

2. Licenses to take or kill such deer may be issued by the Chief Postmaster at Greynouth on payment of a license fee of ± 2 , in the form prescribed in the Schedule hereto, and subject to the said Act and these regulations. The number of such licenses shall not exceed fifteen; provided that not more than one such license shall be issued to the same person.
