was declared to be subject to Part I of the Native Land Settlement Act, 1907, and which by section two hundred and thirty-three of the Native Land Act, 1909, becomes subject to Part XIV of that Act:

And whereas by subsection three of section two hundred and thirty-nine of the Native Land Act, 1909, it is provided that, notwithstanding anything hereinbefore contained in this section, the Governor may by Order in Council, on the recommendation of the Board in whose district the land is situated, in any case in which he is of opinion that an equal division of that land in manner aforesaid would be impracdivision of that land in manner arrorssal would be impracticable or inexpedient in the public interest or in the interests of the owners, authorize the division of that land in any other proportion, or authorize the whole of that land to be disposed of either by sale or lease:

And whereas the Waikato-Maniapoto District Maori Land Board has recommended that it is expedient that the whole of the land set out in the Schedule hereto shall be disposed

of by way of sale:

Now, therefore, His Excellency the Governor of the Do minion of New Zealand, acting by and with the advice and consent of the Executive Council thereof, doth hereby authorize the whole of the said land set out in the Schedule hereto to be disposed of by way of sale; and it is hereby declared that this Order in Council is made under the provisions in that behalf of the Native Land Act, 1909, and shall operate accordingly as a consent of the Governor in Council to the proceedings hereby authorized.
