WHEREAS by section forty-six of the Land Laws Amendment Act, 1913, it is enacted that the Go-vernor, by Order in Council gazetted, may, on the recom-mendation of the Land Board, declare that any land comprised in a kauri-gum reserve shall, from a date to be specified in the Order, cease to be subject to the Kauri-gum Industry Act, 1908, and on and after the date so specified the land to which the Order relates shall become subject to the provisions of the Land Act, 1908:

And whereas the Land Board of the Auckland Land Dis trict has duly passed a resolution recommending that the kauri-gum reserves described in the Schedule hereto be excepted from the operations of the Kauri-gum Industry Act, 1908, and it is expedient to give effect to such recommendation:
