SAN DIEGO BAY APPROACH.—WHISTLE-BUOY MOVED.—On 29th January, 1914, outside bar Whistle-buoy S.D., painted in perpendicular stripes, moored in the approach to San Diego Bay, California, was moved about 2,260 yards, 139°, and re-established in about 17 fathoms of water, on the bearings—

GEORGIA STRAIT.—SEMIAMMOO HARBOUR.—CHARACTERISTIC OF LIGHT CHANGED.—On 28th January, 1914, the characteristic of Semiammo Harbour Light, Georgia Strait, Washington, was changed from fixed red to *intermittent white* every 20 seconds—thus, light 15 seconds, eclipsed 5 seconds.

The luminous power of the light was increased to about 3,200 candles.
