Appointing a Member of the Wanganui Harbour Board.

HEREAS it is provided by section seventeen of the Harbours Amendment Act, 1910, that the office of any member of a Harbour Board shall become vacant if, inter alia, he dies: And whereas it is provided by subsection two of section eighteen of the said Act that when an elective member other than a representative of a combined district vacates his effect on the Board through the control of the said Act that when an elective member other than a representative of a combined district vacates his effect on the Board through the control of the said through the control of the said through the same time. district vacates his office on the Board through the operation of the said section seventeen, the Governor may, by Warrant under his hand, appoint some qualified person in his place:

And whereas James T. Muir, an elective member of the Wanganui Harbour Board, being one of the representatives of the Boroughs of Wanganui and Wanganui East and the Town District of Gonville and Castleeliff, has died, and it is desirable to appoint a qualified person as one of the representative of that district in his place. sentatives of that district in his place:

Now, therefore, the Governor of the Dominion of New Zealand, in exercise of the hereinbefore-recited power and authority, doth hereby appoint William Andrew Veitch to be a member of the Wanganui Harbour Board as one of the representatives of the Combined District of the Boroughs of Wanga-nui and Wanganui East and the Town District of Gonville and Castlecliff, in the place of James T. Muir, deceased.
