of Section 19, Block VI, Glenomaru Survey District, to its junction with a road at the south-east corner of Section 33, Block VI, Glenomaru Survey District; thence in a westerly direction by the centre of the said road and the southern boundary of the said Section 33 to its south-west corner; thence in a northerly direction by the western side of the said Section 33 and Section 37, Block VI, Glenomaru Survey District, to a road-line; thence by the centre of the said road-line in a north-westerly direction to its junction with the Owaka Main Road, on the west side of Section 30, Block VII; thence across the Owaka Main Road to the southern boundary-line of Section 8, Block VII, Glenomaru Survey District; thence by the southern boundary-lines of Sections 8 and 32, Block VII, Glenomaru Survey District, to the western block-line of Block VII, Glenomaru Survey District; thence by the said block-line in a northern direction to the southern block-line of Block III, Glenomaru Survey District; thence by the said block-line in a westerly direction and the southern boundary-line of Section 47, Block IX, Glenomaru Survey District, to the south-west corner of the said Section 47; thence in a northerly direction by the western boundary-lines of Sections 47, 25, and 23 to the south-east corner of Section 59, Block IX, Glenomaru Survey District; thence by the southern boundary-line of the said Section 59 to a road-line; thence by the centre of the said road-line in a northerly direction to the south-west corner of Section 60, Block IX, Glenomaru Survey District; thence by the south-west and southern boundary of Section 60 and southern boundary of Section 61 to the south-west corner of Section 61, thence by the western boundary of the said Section 61 in a northerly direction to the centre of a road-line all in Glenomaru Survey District; thence by the centre of the said road-line in a north-westerly direction to the south-west corner of Section 7, Block III, Catlins Survey District; thence by the western boundary-line of the said Section 7 in a northern direction to the block-line between Block III, Catlins Survey District, and Block X, Warepa Survey District; thence by the said block-line in a western direction to the south-west corner of Section 25, Block IX, Warepa Survey District, the point of commencement.

Waipahi Riding.

All that area in the Clutha County, bounded towards the north generally by parts of Blocks V and VI, Glenkenich Survey District, and by the centre of a road intersecting Blocks IX and X, and Sections 3 and 4, Block XVI, Glenkenich Survey District, to a point in the middle of the Pomahaka River; thence bounded towards the east and north-east generally by the middle of the said river to its confluence with the Wairuna Stream; thence towards the east generally by the said stream to the northern boundary-line of Block III, Waipahi Survey District; thence bounded on the south by the said Block III, Waipahi Survey District; thence bounded on the east by the eastern boundary-line of part of Blocks VII and VI, Waipahi Survey District, to the north-east corner of Section 6, Block VI, Waipahi Survey District; thence by the northern and western boundary-lines of the said Section 6 to a road-line at the south-west corner of the said Section 6, Block VI, Waipahi Survey District; thence bounded towards the south-west and south generally by the centre of the said road-line to the eastern boundary-line of Waikaka Survey District; thence bounded on the west by the said Waikaka Survey District, to its northern boundary-line; thence bounded on the south by the said Waikaka Survey District to the eastern boundary-line of the Chatton Survey District; thence bounded again on the west by part of the said eastern boundary of the said Chatton Survey District to the place of commencement.
