IN pursuance and exercise of the powers vested in him by the Public Works Act, 1908, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby order and declare that the portion of road described in the Schedule hereto shall, on and after the date of this Order in Council, become a county road.

SCHEDULE.

ALL that portion of road in the Wellington Land District, Patea County, known as the Makakaho Road, commencing at the Mangamaire Stream, and proceeding thence in a north-easterly direction generally intersecting Maungaporau Block, Block III, Momahaki Survey District, and terminating at the Rakurawera Stream, being a distance of 1 mile 50 chains, more or less; as the said portion of road is more particularly delineated on the plan marked P.W.D. 35395, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Provincial District, and thereon coloured pink and marked A B.
