Manganui Riding.

Commencing at a point where the northern boundary of Section 11, Block IX, Manganui Survey District, joins the Manganui-o-te-Ao River; thence north-east and south-east by the north and east boundaries of the said Section 11, Block IX, Manganui Survey District, to the north boundary of Block X, Manganui Survey District; thence north-east by the said north boundary of Block X, Manganui Survey District, to the east boundary of Block X, Manganui Survey District; thence south-east by the east boundary of the said Block X, Manganui Survey District, to the Manganui-o-te-Ao River; thence generally east by the Manganui-o-te-Ao River to the northern boundary of the Waimarino County; thence generally east by the said northern boundary of the said Waimarino County to the Ruapehu Trig. Station on the summit of Mount Ruapehu; thence south-west by a straight line to the south-west corner of the Urewera Block; thence north-west, west, and south-west by the east and north boundaries of the said Urewera Block to the centre of the Ohakune-Matapuna Road; thence generally south by the centre of the said Ohakune-Matapuna Road to the north boundary of the Ohakune Borough; thence south-west by the north boundary of the said Ohakune Borough to the centre of the Pipiriki-Ohakune Road; thence generally west by the centre of the Ohakune-Pipiriki Road to the Makotuku Stream (being the east boundary of the Raetihi Riding as described herein); thence north by the said Makotuku Stream to the centre of the Mangarewa Road; thence north-west by the centre of the said Mangarewa Road to the Makotuku Valley Road; thence north-west by the centre of the Raetihi-Ohura Road to the starting-point.

Huikumu Riding.

Commencing at a point where the north and west boundaries of the Raetihi Riding meet (as described herein); thence south by the west boundary of the said Raetihi Riding to the centre of the Pipiriki-Raetihi Road; thence generally west by the centre of the said Pipiriki-Raetihi Road to the centre of the Mangoihe Road; thence generally south by the centre of the said Mangoihe Road to the west boundary of Section 12, Block XII, Rarete Survey District; thence generally north by the west boundary of the said Section 12, Block XII, Rarete Survey District, to the south boundary of Section 15, Blocks XI and XII, Rarete Survey District; thence generally west by the south boundaries of Section 15, Blocks XI and XII, Rarete Survey District, the Scenic Reserve 1B, Block XI, Rarete Survey District, and the Kanaepou Block to the Wanganui River; thence generally north by the Wanganui River to the Manganui-o-te-Ao River; thence generally east by the said Manganui-o-te-Ao River to the centre of the Raetihi-Ohura Road; thence generally south by the said centre of the Raetihi-Ohura Road and the Mangarewa Road to the Makotuku Stream; thence south by the Makotuku Stream to the northern boundary of the Raetihi Riding.

Parapara Riding.

Commencing at a point where the south boundary of the Huikumu Riding joins the Wanganui River (as described herein), thence generally east by the said south boundary of the Huikumu Riding (as described herein) to the western boundary of the Raetihi Riding (as described herein), thence south and east by the west and south boundaries of the Raetihi Riding (as described herein) to the Mangawhero River, thence generally south by the said Mangawhero River to the northern boundary of the Ohakune Riding (as described herein), thence generally west by the said north boundary of the Ohakune Riding to the Wanganui River, thence generally north by the said Wanganui River to the starting-point.

Karioi Riding.

Commencing at a point where the southern boundary of the Manganui Riding (as described herein) joins the eastern boundary of the Raetihi Riding (as described herein), thence east by the said south boundary of the Manganui Riding to the south boundary of the Ohakune Borough, thence generally south by the east boundary of the Ohakune Borough to the centre of the Ohakune-Waiouru Road, thence south-east by the said Ohakune Road to and the south-west boundary of the Rangataua Town District to the Mangaehuehu Stream, thence south by the Mangaehuehu Stream to the Wangaehu River, thence south by the Wangaehu River to the southern boundary of the Waimarino County,

thence south by the said south boundary of the Waimarino County to the east boundary of the Ohakune Riding (as described herein), thence generally north and west by the east and north boundaries of the said Ohakune Riding to the eastern boundary of the Parapara Riding (as described herein), thence generally north by the east boundary of the Parapara Riding to the starting-point.

Ruapehu Riding.

Commencing at the Ruapehu Trig. Station on the summit of Mount Ruapehu; thence east, south, and west by the north, east, and south boundaries of the Waimarino County to the east boundary of the Karioi Riding (as described herein); thence north by the east boundary of the Karioi Riding to the south boundary of the Rangataua Town District; thence generally north, west, and south by the east, north, and west boundaries of the said Rangataua Town District to the north-east boundary of the Karioi Riding; thence west by the aforesaid north-west boundary of the Karioi Riding to the east boundary of the Ohakune Borough; thence generally north by the east boundary of the Ohakune Borough to the east boundary of the Manganui Riding (as described herein); thence generally north-east by the east boundary of the said Manganui Riding to the starting-point.

Raetihi Riding.

Commencing at a point where the northern boundary of the Waimarino County joins the Wanganui River, thence east by the north boundary of the Waimarino County to the north boundary of the Manganui Riding (as described herein), thence south-west by the north boundary of the said Manganui Riding and the north boundary of the Huikumu Riding (as described herein) to the Wanganui River, thence generally north by the said Wanganui River to the starting-point.
