HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by the Public Works Act, 1908, it is in section fifteen thereof, *inter alia*, enacted that, except for the purpose of a railway or defence purposes, or for the purposes of any other work to be made under the authority of a special Act, nothing in this Act contained shall authorize the taking of any land occupied by any building, yard, garden, orchard, or vineyard, or in *bona fide* occupation as an ornamental park or pleasure-ground, without the previous consent of the Governor in Council :

And whereas part of the land described in the Schedule hereto is occupied by buildings, and the Auckland City Council has applied for the consent of the Governor in Council to the taking of the said land for the purposes of widening Beach Road and Jermyn Street in the City of Auckland, and it is expedient that such consent should be given :

Now, therefore, in pursuance and exercise of the above-in-part-recited Act, and of all other powers enabling him in this behalf, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby consent to the land described in the Schedule hereto being taken for the purposes above named.
