Zealand Gazette on the same day, the Attorney-General is
empowered to appoint the Public Trustee as the Controller
of an incorporated company in the cases and circumstances
therein set forth: And whereas the Continental C. and G.
Rubber Company (Limited) is an incorporated company
which has been carrying on business in New Zealand since
the commencement of the present war with Germany:
And whereas the Attorney-General is satisfied that not less
than one-half of the issued share capital thereof is held by
or on behalf of alien enemies, and also that the relation

Now, therefore, I, Alexander Lawrence Herdman, His Majesty's Attorney-General for the Dominion of New Zealand, being satisfied as aforesaid, do hereby, in pursuance of the authority so conferred upon me by the aforesaid regulations, appoint the Public Trustee to be the Controller of the Continental C. and G.
