

## WHANGAMOMONA COUNTY COUNCIL.

RESOLUTION MAKING SPECIAL RATE.—OHURA ROAD  
(CENTRAL RIDING) £2,500 LOAN.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, and the State Advances Act, 1913, the Whangamomona County Council hereby resolves as follows:—

That, for the purpose of providing the interest and other charges on a loan of £2,500, authorized to be raised by the Whangamomona County Council, under the above-mentioned Acts, for the purpose of metalling the Ohura Road in the Central Riding from its junction with the Mangare Road to the Kohuratahi Railway-station, or so far as the money will allow of, the said Whangamomona County Council hereby makes and levies a special rate of one penny three farthings (1½d.) in the pound upon the rateable value of all the rateable property in the Ohura Road (Central Riding) Special Loan of £2,500 Special-rating District, as defined by the special rate roll for the said district; and that such special rate shall be an annual-recurring rate during the currency of such loan, and be payable half-yearly on the first day of January and the first day of July in each and every year during the currency of such loan, being a period of thirty-six and a half years, or until the loan is fully paid off.

COPY OF RESOLUTION MAKING SPECIAL RATE PASSED AT A  
MEETING OF THE MOUNT ALBERT BOROUGH COUNCIL,  
10TH AUGUST, 1914.

Moved by the Mayor, Mr. Murdoch McLean; seconded by Councillor T. B. Clay.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, the Mount Albert Borough Council hereby resolves as follows:—

That, for the purpose of providing the interest and other charges on a loan of £3,000, under the above-mentioned Act (being 10 per cent. additional upon previous loan of £30,000), for the completion of the construction of a portion of the New North Road (allocation "B" in previous loan), the said Mount Albert Borough Council hereby makes and levies a special rate of one-thirtieth of a penny in the pound upon the rateable property of the Mount Albert Borough; and that such special rate shall be an annual-recurring rate during the currency of such loan, and be payable yearly on the 30th day of September in each and every year during the currency of such loan, being a period of 36½ years, or until the loan is fully paid off.

IN pursuance and exercise of the powers vested in it on that behalf by the Local Bodies' Loans Act, 1913, the Whangamarino Road Board hereby resolves as follows:—
