Declaring a Portion of Railway Reserve near Woodville to be Crown Land.

#### LIVERPOOL, Governor. [L.S.] A PROCLAMATION.

WHEREAS by section five of the Public Works Amend-ment Act, 1909, it is provided that in the case of any and taken, purchased, or acquired for a Government work, and not required for that purpose, the Government work, and not required for that purpose, the Governor may, on recommendation by the Minister, by Proclamation, declare such land to be Crown land subject to the Land Act, 1908, and thereupon the land may be administered and disposed of under that Act accordingly:
