SOUTH AUSTRALIA.

*Kangaroo Island.—Backstairs Passage.—Cape St. Albans Light.*

MASTERS of vessels and others are hereby informed that on and after the night of 14th August, 1914, the unwatched fixed light which is at present exhibited from Cape St. Albans will be altered to an unwatched A.G.A. flashing light, showing 20 flashes per minute, as follows: Duration of flash, 0.5 seconds; duration of eclipse, 2.5 seconds.

In clear weather the light should be visible at a distance of 14 miles, and between the same bearings as formerly—that is to say, white between the bearings of 118° (mag. S. 67° E.) and 264° (mag. S. 79° W.), and red from 264° (mag. S. 79° W.) to 355° (mag. N.) over the Scrapper Shoal or till obscured by Cape Willoughby.

Approximate position: Lat. 35° 48' S., long. 138° 7' E.

*Spencer Gulf.—Port Pirie River and Harbour.*

Masters of vessels, pilots, and others are hereby informed that there is now not less than sixteen (16) feet of water, L.W.S., in the channel of the Port Pirie River from the entrance to the harbour, and in the harbour not less than twenty (20) feet.

*West Coast.—Fowler Bay.*

Masters of vessels and others are hereby informed that a Chance Bros. sixth-order port light is now shown from the Fowler Bay Jetty, in lieu of the inferior light shown previously.

The white light is exhibited from a red cast-iron pillar on the sea end of the jetty, the focal plane being 25 ft. above ordinary high water, and showing between the bearings 225° (S. 42° 29' W. mag.) and 315° (N. 47° 51' W. mag.). Light is visible in clear weather for a distance of about 10 miles.
