Regulations for Deer-shooting, Westland.

# LIVERPOOL, Governor.

In vertice of the powers vested in me by the Animals Protection Act, 1908 (hereinafter called "the said Act"), I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, do hereby make the following regulations prescribing the deer-shooting season in the Westland Acolimatization District, exclusive of all sanctuaries, and the conditions affecting the same, and also the form of license and the fee payable therefor.

#### REGULATIONS.

1. RED-DEER stags may be taken or killed in that part of the Westland Acclimatization District known as the Haast, Wills, Landsborough, and Clarke Valleys, South Westland, from the 25th day of March, 1915, to the 30th day of April, 1915 (both days inclusive), and in the remainder of the said dis-

(both days inclusive), and in the remainder of the said district from the 1st day of April, 1915, to the 31st day of May, 1915 (both days inclusive).

2. Licenses to take or kill such deer may be issued by the Chief Postmaster at Hokitika, and the Postmasters at Kumara, Ross, and Okarito, on payment of a license fee of £2, in the form prescribed in the Schedule hereto, and subject to the said Act and these regulations; provided that not more than one such license shall be issued to the same

3. No licensee shall take or kill more than two stags, and no stag shall be killed carrying antiers with less than ten

ounts.

4. No hind or fawn shall be taken or killed on any pretext whatever; and no licensee shall allow any dog to accompany either himself or any attendant he may have with him.

5. Nothing herein contained shall extend to authorizing any person to sell any deer or portion thereof.

6. Any person committing a breach of any of these regulations shall be liable, on conviction, to a fine not exceeding
