ON the recommendation of the Native Land Purchase Board, referred to in section three hundred and sixty-three of the Native Land Act, 1909, and in exercise of the power in this behalf conferred upon him by that section, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby prohibit, for the period of one year from the date of this Order in Council, all alienations of the Native lands specified in the Schedule hereto other than alienations in favour of the Crown.

IN pursuance and exercise of the powers conferred upon him by the Orchard and Garden Diseases Act, 1908, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that on and after the date of the gazetting hereof the diseases named in the Schedule hereto shall be diseases within the meaning of the said Act; and, with the like advice and consent, doth hereby extend the Second Schedule to the said Act by including the aforesaid diseases therein.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

IN pursuance and exercise of the powers vested in him by the Public Works Act, 1908, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby order and declare that a certain road between Sandy Knolls and Kirwee, on the Hurunui-Waitaki Railway (branch from Rolleston to Springfield colliery, with a sub-branch to Whitecliffs), and described in the Schedule hereto, shall, on and after the date of this Order in Council, become a county road.
