WHEREAS by section forty-seven of the Public Reserves and Domains Act, 1908 (hereinafter termed "the said Act"), it is enacted that the Governor may from time to time, by Order in Council gazetted, appoint any local authority to be a Domain Board having, subject to the said Act, control of any public domain:

And whereas by an Order in Council made on the sixteenth day of October, one thousand nine hundred and eight, and published in the *New Zealand Gazette* of the twenty-second day of October, one thousand nine hundred and eight, a Domain Board was appointed to control the Eastbourne Domain:

And whereas the period for which the said Board was appointed expired on the fifteenth day of October, one thousand nine hundred and fifteen:

And whereas it appears expedient to again appoint a Domain Board to control the said domain:

*Exempting certain Goods from Primage Duty.*
