WHEREAS by the Public Works Amendment Act, 1909, W HEREAS by the Public Works Amendment Act, 1909, it is enacted that if at any time after the issue of any Proclamation taking land under the Public Works Act, 1908, and before the payment or award of any compensation in respect of the taking thereof, it is found that the land or any part thereof is not required for the purpose for which it was taken, or that any error in form or substance exists in or in relation to that Proclamation, or the making or gazetting thereof, the Governor may, by a subsequent Proclamation gazetted, revoke the former Proclamation either wholly or so far as he thinks necessary : far as he thinks necessary :

And whereas it is found that the land in the Borough of Lyttelton taken for the purposes of a gasworks by a Pro-clamation made under the Public Works Act, 1908, and dated the nineteenth day of October, one thousand nine hundred and fourteen (hereinafter termed "the said Proclamation"), and published in the New Zealand Gazette No. 113, pages 3826 and 3827, of the twenty-second day of the same month, is incorrectly described :

And whereas compensation in respect of the taking of the said land has not been paid or awarded : Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers vested in me by the Public Works Amendment Act, 1909, and of all other powers enabling me in this behalf, do hereby revoke the said Proclamation.
