I N exercise of the powers vested in me by the Animals Protection Act, 1908 (hereinafter called "the said Act"), I Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, do hereby make the following regulations prescribing the deer-shoot-ing season in that part of the Rotorua Acclimatization District comprised in the part of the County of Wairoa (excluding therefrom the Mahia Peninsula) which is in the said acclimatization district, and the conditions affect-ing the same, and also the form of license and the fee payable therefor. payable therefor.

REGULATIONS.
