IN pursuance and exercise of the powers and authorities conferred by the Public Reserves and Domains Act, 1908 (hereinafter termed "the said Act"), His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby revoke an Order in Council, dated the eighteenth day of October, one thousand nine hundred and nine, and published in the *Gazette* of the twenty-first day of October, one thousand nine hundred and nine, appointing a Domain Board to have control of the Otaki Domain, and doth hereby appoint

OTAKI DOMAIN.

ALL that area in the Wellington Land District, containing by admeasurement 6 acres 0 roods 17 perches, more or less, being part of Haruatai No. 11 Block, situate in Block IX, Waitohu Survey District. Bounded towards the north-west by the Makuratawhiti No. 8A and Haruatai No. 15A Blocks, towards the north-east by part of the Haruatai No. 11 Block, towards the south-east by a public road, and towards the south-west by part of the Haruatai No. 11 Block; as the same is delineated on the plan marked L. 1231, deposited in the Head Office, Department of Lands and Survey, at Wellington, and thereon bordered red.
