RESOLUTION MAKING SPECIAL RATE.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, the Moa Road Board hereby resolves as follows:—

That, for the purpose of providing interest and other charges on a loan of £2,700, authorized to be raised by consent of the ratepayers interested, under the above-mentioned Acts, for the purpose of forming and metalling Lepper Road South, the said Moa Road Board hereby makes and levies a special rate of one penny and two-thirds of a penny in the pound upon the rateable value of all rateable property of the Lepper Road South No. 3 Special-rating Area, comprising part Section 121, containing 20 acres; Sections 122, 123, part 125, containing 40 acres; 126 in two subdivisions, each containing 90 acres; 127 in four subdivisions, containing 90 acres, 64 acres, 64 acres, and 178 acres; and Section 147, Block IV, Egmont S.D.; Sections 138, 143, 144, 145, and 146, Block III, Egmont S.D.; and Sections part 7, containing 79 acres 0 roods 16 perches; 8, 9, in two subdivisions, containing 65 acres 1 rood 4 perches and 1 rood 32 perches; 10, 11, 12, 13, 28, and 30, Block VII, Egmont S.D.:
