the same is used or occupied by the said club for a race meeting, namely:—
(a.) Bookmakers.

(b.) All persons under disqualification inflicted by any racing club in the Dominion of New Zealand, the Commonwealth of Australia, or elsewhere, if affiliated with the Racing Conference of New Zealand.

(c.) Common prostitutes, and persons who habitually consort with thieves or with persons who have no lawful visible means of support.

The foregoing regulations of the Ashburton County Racing Club were made and passed by the Ashburton County Racing Club on the seventeenth day of December, 1915, and signed by the Chairman and Secretary.

P OR Deaf Children of sound intellect. The pupils are taught to understand and use ordinary speech. full charge for board and education is £40 a year, but less is accepted from parents who cannot afford to pay this amount. In case of necessity admission is free.

By the Education Act it is compulsory for deaf children to come under instruction at the age of six, and to continue until the age of twenty-one unless the Education Department previously grants exemption. Though a child is, as a rule, best fitted to begin the school course at the age of six, advice should be obtained as soon as any sign of deafness is observed.

The following classes of deaf children are admitted to the School for the Deaf (sound intellect being always a necessity) :-

1. Children born deaf, or who have lost their hearing

before learning to speak.
Children who can hear a little, but are too deaf to be taught in a public school.
Children who have lost their hearing after having learned to speak.

The Act impose upon every parent, teacher of a school (either public or private), constable, or officer of a cenaritable or kindred institution who is aware of the place of residence (either temporary or permanent) of a deaf child, and the householder in whose house any such child resides, an obligation to send notification of the fact to the Minister of Education, giving the name, age, and address of the child: and any neglect or failure to comply with this provision involves liability to a fine.
