

Now, therefore, in pursuance and exercise of the powers conferred upon him by the said section, and of all other powers in anywise enabling him in that behalf, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth, subject to the conditions set forth in the Schedule hereto, and to the regulations made under section two of the aforesaid Act and published in the *New Zealand Gazette* dated the twenty-ninth day of April, one thousand nine hundred and fifteen, and hereinafter referred to as "the regulations," hereby authorize the licensee to erect and maintain electric lines for lighting, power, and heating purposes within the area of supply hereinafter described.

#### SCHEDULE.

##### 1. AREA OF SUPPLY.

The area of supply comprises the Borough of Riccarton as at present constituted.

##### 2. SYSTEM OF SUPPLY.

The system of supply shall be as described in paragraph 2 (c) of clause 2 of the regulations.

##### 3. DATUM TEMPERATURE.

For the purpose of calculating the stresses as provided in clause 12 of the regulations, the datum temperature shall be taken as 12 degrees Fahrenheit.

##### 4. NOTICES *re* EXTENSIONS, ETC.

Records of results of tests (Regulation 37), and notices *re* commencement of work (Regulation 44) and *re* extensions and alterations (Regulation 49), should be sent to the Under-Secretary, Public Works Department, Wellington, and to the Telegraph Engineer of the district, or his Deputy, at present stationed at Christchurch.

##### 5. CHARGES FOR ELECTRIC ENERGY.

The charge for electrical energy shall not exceed 9d. per unit for lighting purposes, and 4d. per unit for motor-power, heating, or cooking purposes; provided that "lighting purposes" shall include the operation of motor generators for lighting purposes.

##### 6. DURATION OF LICENSE.

This license shall, unless sooner determined in accordance with the provisions hereinafter expressed, continue in force for a period of forty-two years from the date hereof. Upon the expiry of the said term, or upon the sooner determination of this license by revocation or otherwise, all rights hereby granted to the licensee shall thereupon cease and determine; but such expiration or determination shall not relieve the licensee of any liability theretofore incurred under this license.

##### ORDER IN COUNCIL.

At the Government House at Wellington, this twentieth day of November, 1916.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by section twelve of the War Funds Act, 1915 (hereinafter referred to as "the said Act"), it is provided that the Governor may, by Order in Council gazetted, incorporate a society possessing a war fund, or the trustees of such fund: And whereas application, in writing addressed to the Minister, has been made by the Marlborough Patriotic Fund Society (being a society possessing a war fund), praying for the incorporation of that society:

And whereas it is considered desirable to grant such application:

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, in pursuance and exercise of the power and authority vested in him by the said Act, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby order and declare that the society known as the Marlborough Patriotic Fund Society is hereby incorporated for the purposes of the said Act as from the publication hereof in the *New Zealand Gazette*, and shall be known as the "Marlborough Patriotic Association."

*Prohibiting all Private Alienation of certain Native Land.*

##### ORDER IN COUNCIL.

At the Government House at Wellington, this twentieth day of November, 1916.

Present :

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

ON the recommendation of the Native Land Purchase Board, referred to in section three hundred and sixty-three of the Native Land Act, 1909, and in exercise of the power in this behalf conferred upon him by that section, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby prohibit, for the period of one year from the date of this Order in Council, all alienations of the Native land specified in the Schedule hereto other than alienations in favour of the Crown.
