CHRISTCHURCH FIRE BOARD.

BY-LAW NO. 4 (1916), RELATING TO NOTICES OF TERMINATION OF AGREEMENT FOR SERVICE OF PAID MEMBERS OF THE CHRISTCHURCH FIRE BRIGADE.

In pursuance of the powers and authorities vested in it by the Fire Brigades Act, 1908, and of all and each and every other power in that behalf enabling it, the Christchurch

The short title of this by-law shall be "Christchurch Fire Board By-law No. 4 (1916)." This by-law shall be read with and form part of the Christchurch Fire Board By-law No. 1 (1910) in like manner as if the same had been enacted therein, and shall come into force on the 8th day of February, 1916. From and after the coming into force of this by-law clause 5 of Part II of the Christchurch Fire Board By-law

No. 1 (1910) shall be repealed, and the following clause shall be substituted therefor: --(5) Unless with the written consent of the Board, one

week's notice shall be given by a member to the Board of his intention to terminate the agreement of service with the Board, and the service of a member of the brigade shall be liable to be terminated by the Board on one week's written notice being given to that effect to such member, and on payment to such member of all pay due to him up to the expiration of such notice. If any member leaves without the written consent of the Board, or without giving such notice on his part, he will forfeit all pay due to him, and further will be liable to be formally dismissed by the Board
