In pursuance and exercise of the powers and authorities vested in me by the Mining Act, 1908 (hereinafter termed "the said Act"), and of all other powers enabling me in this behalf, 1, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, do hereby revoke the Proclamation constituting the Puhi-puhi Mining District, published in the New Zealand Gazette No. 130, of the eighteenth day of November, one thousand nine hundred and fifteen, and in lieu thereof do hereby pro-claim and declare that the boundaries of the said district shall be those mentioned in the Schedule hereto. And L do shall be those mentioned in the Schedule hereto. And I do hereby further proclaim and declare that this Proclamation shall take effect as from the date of gazetting hereof.

SCHEDULE

PUHIPUHI MINING DISTRICT.
