And whereas an agreement has been entered into between the Education Board of the Education District of Wanganui and the owners of the land described in the Schedule hereto to take such land for the purposes of a public school:

And whereas the Education Board of the Education District of Wanganui has laid before the Governor a memorial, accompanied by a map in duplicate, as required by the said Act:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1908, and the Education Act, 1908, and of every other power and authority in anywise enabling me in this behalf, and being satisfied of the sufficiency of the said agreement, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for the purposes of the said public school as from the date hereinafter specified, and shall vest in the Education Board of the Education District of Wanganui; and I do also hereby direct that this Proclamation shall take effect on and after the thirty-first day of January one thousand nine hundred and sixteen.
