Notice under the War Regulations declaring certain Persons, Firms, and Companies to be Enemies.

WHEREAS the Attorney-General for the Dominion of New Zealand is satisfied that the companies, firms, and persons mentioned in the First Schedule hereto are carrying on business to a substantial extent for the benefit of alien enemies resident out of New Zealand :

And whereas he is satisfied that the persons named in the Second Schedule hereto are alien enemies resident out of New Zealand and carrying on business in that Dominion:

Now, therefore, I, Alexander Lawrence Herdman, His Majesty's Attorney-General for the Dominion of New Zealand, do hereby, in pursuance of clause 20 of the War Regulations of the 3rd day of April, 1916, under the War Regulations Act, 1914, declare each of the companies, firms, and persons mentioned in the Schedules hereto to be an enemy.

License under the War Regulations for the Winding-up of Enemy Business.

WHEREAS the companies, firms, and persons mentioned in the Schedule hereto have been declared by the Attorney-General, in pursuance of the War Regulations of the 3rd day of April, 1916, to be enemies: 1103

Now, therefore, I, Alexander Lawrence Herdman, His Majesty's Attorney-General for the Dominion of New Zealand, do hereby, in pursuance of clause 20 of the said regulations, notwithstanding the said declaration, authorize and permit all transactions which may be necessary for the winding-up of the business of the said companies, firms, and persons or for the performance of existing contracts; provided that such transactions take place with the knowledge and consent of the Custodian of Enemy Property or of some person appointed by him in that behalf.
