### LIVERPOOL, Governor. [L.S.] A PROCLAMATION.

WHEREAS by section one hundred and thirty-three of W The Land Act, 1908, it is enacted that the Governor, by Proclamation, may from time to time declare any Crown lands within any mining district not held under lease or license, or for which a lease or license has been cancelled, to be open for disposal as provided in section one hundred and thirty-five of the said Act:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, in exercise of the power and authority conferred upon me by the one hundred and thirty-third section of the said Act, and of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the lands described in the Schedule hereto shall be open on Monday, the sixth day of March, one thousand nine hundred and sixteen, for disposal as provided in section one hundred and thirty-five of the said Act.

## First-class Land.

SECTION 131, Block XIII: Area, 60 acres 3 roods; capital value, £300; half-yearly rent, £6. Weighted with £100, valuation for improvements. All agricultural land of fair quality. Three acres mixed bush; balance felled and grassed, but somewhat overgrown with fern and blackberries. About six miles from Murchison Dairy Factory by good dray-road.

WHEREAS by section one hundred and thirty-three of the Land Act 1000 if is marked in thirty-three of VV the Land Act, 1908, it is enacted that the Governor, by Proclamation, may from time to time declare any Crown lands within any mining district not held under lease or license, or for which a lease or license has been cancelled, to be open for disposal, as provided in section one hundred and thirty-five of the said Act: Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand,

in exercise of the power and authority conferred upon me by section one hundred and thirty-three of the said Act, and of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the sections of land as described in the Schedule hereto shall be open on Monday, the sixth day of March, one thousand nine hundred and sixteen, for disposal, as provided in section one hundred and thirty-five of the said Act; and I do also declare that the sections of land described in the Schedule hereto shall be deemed to be heavy-bush land.

After the first half-year's rent has been paid by the selector the further instalments of rent payable by him for a period of four years shall not be demanded; provided that if at any time during the first five years of his occupancy the selector disposes of his interest in the land the rent so conceded shall be paid by him in full, and thereupon the Land Board may remit such instalments of rent payable by the incoming tenant, not exceeding in the aggregate the amount of rent previously conceded to the selector, as the Board shall think fit.

## Second-class Heavy-bush Land.

(Exempt from Rent for Four Years.)

Broken terrace country. Soil fair, on limestone formation; steep slope to river access to terrace. Access by pack-track up Fox's River.

Section 11,\* Block V: Area, 314 acres; rent per acre per annum (approximate), 8d.; capital value, £250; half-yearly rent, £5.
