And whereas application has been made for the consent of the Governor in Council to enable the several local autho-rities mentioned in the Schedule hereto to borrow the loans set out in column B therein from the State Advances Office : And whereas it is expedient that the precedent consent of the Governor in Council should issue :

Now, therefore, His Excellency the Governor of the Do-minion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion,
