SCHEDULE.

ALL that portion of road in the Wellington Land District, Waimarino County, known as the Waiouru-Tokaanu Road, commencing at its junction with the Ohakune-Waiouru and Waiouru-Taihape Roads, and proceeding in a north-easterly direction, adjoining or passing through Section 7, Town of Waiouru, Block IX, Moawhango Survey District, Waiouru Reserve, and part Rangituhia Block, Block IX aforesaid, and terminating at a point one mile from the aforesaid junction: being a distance of eighty chains, more or less. As the said portion of road is more particularly delineated on the plan marked P.W.D. 40005, and deposited in the office of the Minister of Public Works at Wellington, in the Wellington Provincial District, and thereon coloured red.

SCHEDULE.

ALL that portion of road in the Hawke's Bay Land District, Hawke's Bay County, known as Mangahouhou Road, commencing at a point marked B on the eastern boundary of Section 5, Block XI, Patoka Survey District, about a quarter of a mile on the Ngaroto side of the Manganoe Stream Bridge, and proceeding thence in a north-westerly direction generally, adjoining or passing through the said Section 5, and terminating at a point F on the northern boundary of the said section opposite the Waihai Homestead; being a distance
