IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, the Franklin County Council hereby resolves as follows:—

That, for the purpose of providing the interest and other charges on a loan of one hundred pounds, authorized to be raised by the Franklin County Council, under the above-mentioned Act, for the purpose of formation and metalling of Jamieson's Road, Buckland, the said Franklin County

MOKOPEKA-KAHURANAKI ROAD LOAN.—RESOLUTION MAKING SPECIAL RATE.

IN pursuance and exercise of the powers vested in them by the Local Bodies' Loans Act, 1913, the Hawke's Bay County Council do hereby resolve as follows:—

That, for the purpose of providing the interest and other charges on a loan of £3,000, authorized to be raised by this Council, under the above-cited Act, to defray one-half the estimated cost of constructing a public road leading from a point on the Hastings-Waimarama Road about twenty chains from the eastern end of the Waimarama Bridge through the Kidnapper and Kauranaki Crown-grant Districts to the Hawea Road, the Council do hereby make and levy a special rate of one penny in the pound upon the capital value of all rateable property within the Mokopeka-Kahuranaki Special-rating District, being the area described in the Schedule hereto. The said special rate to be an annually recurring rate during the term or currency of the said loan, and to be payable half-yearly on the first day of February and the first day of August in each year during that term (being a period of ten years from the first day of August, one thousand nine hundred and sixteen), or until the loan is fully paid off; the rate of interest on the said loan to be five pounds five shillings (£5½) per centum per annum."

THE SCHEDULE ABOVE REFERRED TO.
