- (a.) For the relief of distress occasioned by the war in which His Majesty is at present engaged, whether such distress exists in New Zealand or elsewhere in the British Dominions, or in any country allied to His Majesty
- (b.) For any patriotic objects approved for the purposes of this Act by the Governor: Provided that every such contribution is paid either-

- Into a public fund established by the Government, or by any local authority, for the purposes of such relief of distress, or patriotic objects; or
  Into a fund established by persons other than the Government or a local authority, where such fund and the conditions of control and expenditure thereof are approved for the purposes of this Act by the Governor. by the Governor:

And whereas certain persons in the Provincial District of Auckland have formed themselves into a committee known

Auckiand have formed themserves into a committee known as the Mayor of Auckiand's Serbian Relief Fund, for the following purposes, namely:— To provide relief for the distress caused to Serbian sub-jects in Europe by the war, and for that purpose to take all steps necessary to collect moneys and goods to be forwarded to the Serbian Ambassador in London for distribution. for distribution :

And whereas the said committee has established a fund for the promotion of the objects hereinbefore expressed, and has submitted the said fund and the conditions of control and the expenditure thereof for approval, as required by the hereinbefore-quoted provisions of the said Act: Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand,
