A PROCLAMATION.

WHEREAS by section sixty-three of the Land Laws
Amendment Act, 1913, it is, amongst other things,
enacted that in no case shall any moneys be expended
under the provisions of the said section sixty-three in connection with any block of land, unless that block is set apart for selection under that section pursuant to Proclamation

in that behalf:
Now, therefore, in pursuance and exercise of every power and authority enabling me in this behalf, and for the purposes of the aforesaid Act, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor General of the Dominion of New Zealand, do hereby proclaim the land described in the Schedule hereto as set apart for selection.

SCHEDULE

HAWKE'S BAY LAND DISTRICT.

Awa-o-totara Block.

SECTIONS 1 and 2, Block IV, Maungaharuru Survey District; and Sections 1 to 5 (inclusive), Block I, 2 to 7 (inclusive), Block II, 1, Block V, and 1 to 4 (inclusive), Block VI, Moeangiangi Survey District: Area, 16,856 acres 0 roods 20 perches.

As the same is delineated upon the plan marked L. and S. 5/99, deposited in the Head Office, Department of Lands and Survey, at Wellington, and thereon edged green.
