

*Crown Land in Block VI, Whakatane Survey District, set apart for the Purposes of a Road.*

A PROCLAMATION.

WHEREAS the land mentioned in the Schedule hereto is Crown land, and is required to be set apart for the purposes of a road in Block VI, Whakatane Survey District:

And whereas by section twenty-one of the Public Works Act, 1908, it is enacted that whenever any Crown land is required to be set apart for any public work, the Governor may at any time, by Proclamation, set the same apart for such public work without complying with any of the provisions of that Act in respect of the taking or setting-apart of other lands for such purpose:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1908, and of every other power and authority in anywise enabling me in that behalf, do hereby proclaim and declare that the land described in the Schedule hereto is hereby set apart for the purposes of the said road; and I also hereby declare that this Proclamation shall take effect on and after the eighth day of August, one thousand nine hundred and seventeen.

#### SCHEDULE.

APPROXIMATE area of the piece of land set apart: 1 acre 0 roods 19·7 perches, being below high-water mark, Ohiva Harbour, Block VI.

Situated in Whakatane Survey District. (S.O. 18726.)

*Declaring Land taken for a Public Work, and not required for such Public Work, to be Crown Land.*

A PROCLAMATION.

WHEREAS it is provided by section thirty of the Public Works Act, 1908, that if it is found that any land held, taken, purchased, or acquired at any time under this or any other Act or Provincial Ordinance, or otherwise howsoever, for any public work is not required for such public work the Governor may, by an Order in Council publicly notified and gazetted, cause the same to be sold under the conditions therein mentioned:

And whereas it is further provided by section five of the Public Works Amendment Act, 1909, that in the case of any land so taken, purchased, or acquired for a Government work, and not required for that purpose, the Governor may, on the recommendation of the Minister, and without complying with any other requirements of the aforesaid section thirty, by Proclamation declare such land to be Crown land subject to the Land Act, 1908, and thereupon the land may be administered and disposed of under that Act accordingly:

And whereas the land described in the Schedule hereto was taken for the purposes of a road: And whereas the said road has been stopped, and it is desirable to declare the land contained therein to be Crown land:

And whereas a plan has been prepared, and the Minister has recommended the Governor-General to declare such land to be Crown land:

Now, therefore, in pursuance and exercise of the powers and authorities conferred upon me by the above-in-part-recited Acts, and of all other powers in anywise enabling me in this behalf, I, Arthur William de Brito Savile, Earl

of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby declare the land described in the Schedule hereto to be Crown land subject to the Land Act, 1908, and that such land may be administered and disposed of under that Act accordingly.

#### SCHEDULE.

APPROXIMATE area of the piece of stopped road declared to be Crown land: 2 acres 2 roods 32 perches.

Adjoining or passing through Sections 52 and 53, Block II, Mount Fyffe Survey District (Marlborough R.D.).

#### A PROCLAMATION.

WHEREAS by paragraph (c) of section one hundred and thirty-three of the Public Works Act, 1908, it is enacted that the Governor may, by Proclamation publicly notified, stop or alter the course of any Government road or any part thereof:

And whereas the Government roads described in the Schedule hereto are no longer required for the purpose of roads:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, in pursuance and exercise of the above-in-part-recited Act, and of all other powers in anywise enabling me in this behalf, do hereby proclaim as stopped the roads described in the Schedule hereto.
