REGULATIONS.

(Under the Gaming Act, 1908.)

In pursuance and exercise of the powers in that behalf con-tained in section 33 of the Gaming Act, 1908, and of all other powers and authorities it enabling in that behalf, the Qamaru Trotting Club, a trotting club within the meaning of the said Act (and hereinafter referred to as "the said club"), doth hereby make the following regulations controlling the admis-sion of persons to that part of the racecourse reserve situate at North Road, Oamaru, and set apart for racing purposes, and known as the Oamaru Trotting Club Racecourse, while the same is used and occupied by the said club for race meetings.
