RESOLUTION.

THE following regulations were laid before the members of the Rangitikei Hunt Club at a meeting held on the tenth day of July, 1917, at Marton, with a recommendation by the Chairman of the Club, Mr. D. G. Riddiford, that the same be passed at once with a view to their approval by the Governor-General, in pursuance of the Gaming Act, 1908,

Mr. D. G. Riddiford, the Chairman of the Club and the Meeting, moved, and Mr. W. J. Simpson seconded, and it was resolved, that such regulations should be adopted, and that the Chairman be authorized to sign the same in authentication thereof.

The following are the regulations referred to:-

RANGITIKEI HUNT CLUB.

REGULATIONS.

(Under the Gaming Act, 1908.)

In pursuance and exercise of the powers in that behalf con-In pursuance and exercise of the powers in that behalf contained in section 33 of the Gaming Act, 1908, and of all other powers and authorities it enabling in that behalf, the Rangitikei Hunt Club, a racing club within the meaning of the said Act (hereinafter referred to as "the said club"), doth hereby make the following regulations controlling the admission of persons to that part of the grounds situate in the District of Rangitikei, and known as the Marton Racecourse, while the said racecourse is used or occupied by the said club for race meetings. for race meetings.

1. In these regulations the words "bookmaker," "racing club," and "race meeting" shall have the meanings ascribed to those terms by section 2 of the Gaming Act, 1908.

2. The following persons shall be and are hereby excluded from the racecourse above described while the same is used or occupied by the said club for a race meeting, namely:—

(a.) Bookmakers.

(b.) All persons under disqualification inflicted by any racing club in the Dominion of New Zealand, the Commonwealth of Australia, or elsewhere, if affiliated to the New Zealand Racing Conference.

(c.) Common prostitutes, and persons who habitually consort with thieves or with persons who have no law-

ful visible means of support.

The foregoing regulations of the Rangitikei Hunt Club were made and passed by the Rangitikei Hunt Club on the tenth day of July, 1917, and signed by the Chairman and Secretary.
