RESOLUTION.

THE following regulations were laid before the members of the Hawke's Bay Hunt Club at a special meeting held on Wednesday, 11th July, 1917, at 10.30 a.m., with a recommendation by the Chairman of the Club, Mr. H. Hassall, that the same be passed at once with a view to their approval by the Governor-General, in pursuance of the Gaming Act, 1908, section 33.

Mr. H. Hassall, Chairman of the Club and the Meeting, moved, and Mr. J. H. Macniven seconded, and it was resolved, that such regulations should be adopted, and that the Chair man be authorized to sign the same in authentication thereof.

The following are the regulations referred to:-

1. In these regulations the words "bookmaker," "racing club," and "race meeting" shall have the meanings ascribed to those terms by section 2 of the Gaming Act, 1908.

2. The following persons shall be and are hereby excluded from the Hawke's Bay Jockey Club's Racecourse while the same is being used or occupied by the Hawke's Bay Hunt Club for a race meeting, namely:—

(a.) Bookmakers, bookmakers' clerks, betting agents, and

layers of starting-prices, and all persons who have been guilty of any malpractice or dishonourable conduct in connection with racing or betting, or have been warned off any racecourse by any racing

(b.) All persons under disqualification inflicted by any racing club in the Dominion of New Zealand, the Commonwealth of Australia, or elsewhere, if affiliated to the New Zealand Racing Conference.

(c.) Common prostitutes, and persons who habitually consort with thieves or with persons who have no lawful visible means of support.

3. No person as in the preceding sections is mentioned shall obtain the right to come and go upon the racecourse or to remain thereon by reason of his being a member of any racing or jockey club, or of his having paid any fee or obtained any ticket of admission, and his ejection from the course shall give him no right to a return of his fee or ticket.
