Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1908, and the Municipal Corporations Act, 1908, and their amendments, the Wellington City Empowering Act, 1897, the Wellington City Empowering Act, 1899, and the Wellington City Empowering Act, 1908, and of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for the purposes of widening the said street and road, and shall vest in the Mayor, Councillors, and Citizens of the City of Wellington on and after the date hereinafter mentioned; and I do also hereby declare that this Proclamation shall take effect on and after the first day of September, one thousand nine hundred and seventeen.
