N the recommendation of the Native Land Purchase Board, referred to in section three hundred and sixty-Board, reterred to in section three hundred and sixty-three of the Native Land Act, 1909, and in exercise of the power in this behalf conferred upon him by that section, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council thereof, doth hereby extend for a further period of six months the Order in Council dated the sixtenth day of October one thousand size harded. sixteenth day of October, one thousand nine hundred and sixteen, and gazetted the nineteenth day of October, one thousand nine hundred and sixteen, prohibiting all alienations of the Native land specified in the Schedule hereto other than alienations in favour of the Crown.
