ORDER IN COUNCIL.

At the Government House at Wellington, this twenty-ninth day of January, 1917.

Present :

THE HONOURABLE JAMES ALLEN PRESIDING IN COUNCIL.

WHEREAS by section forty of the Public Reserves and Domains Act, 1908 (hereinafter termed "the said Act"), it is enacted that the Governor may from time to time, with respect to any public domain, appoint such persons (not exceeding nine) as he thinks fit to be a Domain Board having, subject to Part II of the said Act, control of such domain :

And whereas by an Order in Council made on the eighteenth day of November, one thousand nine hundred and nine, and published in the *New Zealand Gazette* of the twenty-fifth day of November, one thousand nine hundred and nine, a Domain Board was appointed to control the Oturehua Domain :

And whereas the period for which the said Board was appointed expired on the seventeenth day of November, one thousand nine hundred and sixteen :

And whereas it appears expedient to again appoint a Domain Board to control the said domain :

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, in exercise of the powers conferred by the said Act, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby appoint

SCOTSBURN DOMAIN.

ALL that area in the Canterbury Land District, containing by admeasurement 50 acres, more or less, being Reserve 1554 (in red), Block III, Orari Survey District. Bounded towards the north-east by a road-line, 2850 links ; thence towards the south-east by Rural Section 19332, 3519 links ; thence towards the west by a road-line, 4529 links : be all the aforesaid linkages more or less : as the same is delineated on the plan marked L. 1253, deposited in the Head Office, Department of Lands, at Wellington, and thereon bordered red.

Extending Prohibition of Private Alienation of certain Native Land.

THE HONOURABLE JAMES ALLEN PRESIDING IN COUNCIL.

ON the recommendation of the Native Land Purchase Board referred to in section three hundred and sixty-three of the Native Land Act, 1909, and in exercise of the power in this behalf conferred upon him by that section, and by section one hundred and eleven of the Native Land Amendment Act, 1913 (as amended by section eight of the Native Land Amendment and Native Land Claims Adjustment Act, 1916), His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council thereof, doth hereby extend for a further period of twelve months the Order in Council made and gazetted the sixth day of February, one thousand nine hundred and fifteen, which Order in Council
