RESOLUTION MAKING SPECIAL RATE.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, the Waikato County Council hereby resolves as follows:—

That, for the purpose of providing the instalments in respect of principal and interest and also the other charges on a loan of £400, authorized to be raised by the Waikato County Council, under the Local Bodies' Loans Act, 1913, for the purpose of widening and deepening Stubbings Creek, the said Waikato County Council hereby makes and levies a special rate of $\frac{5}{8}$ d. in the pound upon the rateable value of all rateable property classified A as set out in the Schedule hereunder, one-half of a penny in the pound upon the rateable value of all rateable property classified B as set out in the Schedule hereunder; and that such special rate shall be an annual-recurring rate during the currency of such loan, and be payable half-yearly on the 1st day of February and the 1st day of August in each and every year during the currency of such loan, being a period of $36\frac{1}{2}$ years, or until the loan is fully paid off.

RESOLUTION MAKING SPECIAL RATE.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, the Kawhia County Council hereby resolves as follows:—

That, for the purpose of providing the instalments in respect of principal and interest and also the other charges on a loan of two hundred pounds, authorized to be raised by the Kawhia County Council, under the Local Bodies' Loans Act, 1913, for completing the metalling of the Pirongia West Road, the said Kawhia County Council hereby makes and levies a special rate of one farthing in the pound upon the rateable value of all rateable property of the Pirongia West Special-rating Area, as described in a resolution of the said Council published on page 769 of the *New Zealand Gazette* of the 5th March, 1914; and that such special rate shall be an annual-recurring rate during the currency of such loan, and be payable yearly on the 17th day of August in each and every year during the currency of such loan, being a period of $36\frac{1}{2}$ years, or until the loan is fully paid off.

RESOLUTION MAKING SPECIAL-RATE LOAN OF £1,200, MAKINO ROAD.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, the Rangitikei County Council hereby resolves as follows:—

That, for the purpose of providing the instalments in respect of principal and interest and also the other charges on a loan of £1,200, authorized to be raised by the Rangitikei County Council, under the Local Bodies' Loans Act, 1913, for the purpose of widening and metalling the Makino Road, and the cost of raising the loan to be paid out of the loan, the said Rangitikei County Council hereby makes and levies a special rate of twopence and two-thirds of a penny ($2\frac{2}{3}$ d.) in the pound sterling upon the rateable value (on the basis of the capital value) of all rateable property of the Makino
