And whereas the Wellington City Council has certified that the signatures to such requisition represent a majority of the occupiers of all the (a) hairdressers' and (b) tobacconists' shops within the City of Wellington:

Now, therefore, I, William Ferguson Massey, Minister of Labour, in pursuance of section 25 of the Shops and Offices

Act, 1908, do hereby direct that on and after the 20th day of December, 1917, all hairdressers' shops and all tobacconists' shops within the City of Wellington shall be closed accordingly.

The notice gazetted on the 21st day of September, 1911, is hereby varied accordingly.
