WHEREAS by section twenty-six, subsection one, of the Appropriation Act, 1915, it is provided that, VV the Appropriation Act, 1915, it is provided that, notwithstanding any Act to the contrary, it shall not be lawful or competent for any local authority or for any Har-bour Board during the present war with Germany to borrow or contract to borrow any money (otherwise than by way of bank overdraft within the limit of its powers, if any, in that behalf) whether from the State Advances Office, or from any other source whataver and whether in pursuance of a special other source whatever, and whether in pursuance of a special Act or under any other authority whatever, without the pre-cedent consent of the Governor in Council :

And whereas application has been made for the consent of the Governor in Council to enable the several local authori-ties mentioned in the Schedule hereto to borrow the loans set out in column B therein : And whereas it is expedient that the precedent consent of the Governor in Council should issue :
