## A PROCLAMATION.

WHEREAS the land described in the Schedule hereto is required to be taken, under the Public Works Act, 1908, for a certain public work—to wit, for gasworks purposes in the Borough of Hamilton:

And whereas the Hamilton Borough Council has laid before the Governor a memorial, accompanied by a map in duplicate, and also the statutory declaration, as required by the said Act:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1908, and the Municipal Corporations Act, 1908, and of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for gasworks purposes, and shall vest in the Mayor, Councillors, and Burgesses of the Borough of Hamilton on and after the date hereinafter mentioned; and I do also hereby declare that this Proclamation shall take effect on and after the twenty-first day of March, one thousand nine hundred and seventeen.

## A PROCLAMATION.

WHEREAS by the Public Works Amendment Act, 1909, it is enacted that if at any time after the issue of any Proclamation taking land under the Public Works Act, 1908, and before the payment or award of any compensation in respect of the taking thereof, it is found that the land or any part thereof is not required for the purpose for which it was taken, or that any error in form or substance exists in or in relation to that Proclamation, or the making or gazetting thereof, the Governor may, by a subsequent Proclamation gazetted, revoke the former Proclamation either wholly or so far as he thinks necessary: And whereas it is found that the land in the Borough of Lyttelton taken for the purposes of a gasworks by a Proclamation made under the Public Works Act, 1908, and dated the nineteenth day of March, one thousand nine hundred and fifteen (hereinafter termed "the said Proclamation"), and published in the *New Zealand Gazette* No. 44, page 953, of the twenty-fifth day of the same month, is not now required for the purposes for which it was taken: And whereas compensation in respect of the taking of the said land has not been paid or awarded:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers vested in me by the Public Works Amendment Act, 1909, and of all other powers enabling me in this behalf, do hereby revoke the said Proclamation.
