A PROCLAMATION.

WHEREAS by section sixty-three of the Land Laws Manadament Act, 1913, it is, amongst other things, enacted that in no case shall any moneys be expended under the provisions of the said section sixty-three in con-nection with any block of land, unless that block is set apart for selection under that section pursuant to Proclamation

In that behalf: Now, therefore, in pursuance and exercise of every power and authority enabling me in this behalf, and for the purposes of the aforesaid Act, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, do hereby proclaim the land described in the Schedule hereto as set apart for selection.

SCHEDULE.

HAWKE'S BAY LAND DISTRICT. Tiratu Block.

SECTIONS 9 to 22 (inclusive) and 24 to 44 (inclusive), Block IV, Tahoraiti Survey District: Area, 5,505 acres.

As the same are delineated upon the plan marked L. and S. 5/89, deposited in the Head Office, Department of Lands and Survey, at Wellington, and thereon edged pink.
