And whereas by subsection three of section two hundred and thirty-nine of the Native Land Act, 1909, it is provided that, notwithstanding anything hereinbefore contained in that section, the Governor may by Order in Council, on the recommendation of the Board in whose district the land is situated, in any case in which he is of opinion that an equal division of that land for disposal by sale and lease would be impracticable or inexpedient in the public interest or in the interests of the owners, authorize the division of that land in other than equal proportions, or authorize the whole of in other than equal proportions, or authorize the whole of that land to be disposed of either by sale or lease: And whereas the Waikato-Maniapoto District Maori Land

Board has recommended that it is expedient that the whole of the land described in the Schedule hereto should be disposed of by way of sale, and the Governor is of opinion that it

should be so disposed of:

N the recommendation of the Native Land Purchase Board, referred to in section three hundred and sixty-three of the Native Land Act, 1909, and in exercise of the power in this behalf conferred upon him by that section, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council thereof, doth hereby extend for a further period of six months the Order in Council made the twenty-first day of March, one thousand nine hundred and sixteen, and gazetted the thirtieth day of March, one thousand nine hundred and sixteen, but only in so far as such Order in Council prohibits all alienations of the lands specified in the Schedule hereto other than alienations in favour of the Crown.
